Form 2290 for July 2005--Major Changes

Beginning with Form 2290 due for the period July 1, 2005 through June 30, 2006, the balance due shown on the form must be paid in full. The American Jobs Creation Act of 2004 eliminated the election to pay the tax due in installments.

Also, if a Canadian or Mexican vehicle is registered in your name, the reduced tax rates no longer are applicable to these vehicles. The reduced rates shown on the Tax Computation worksheet will apply only to logging vehicles.
