Dear

This responds to a letter dated September 19, 2000, written on behalf of \underline{X} , requesting a ruling under § 1362(b)(5) of the Internal Revenue Code.

<u>A</u>, <u>X</u>'s sole shareholder, represents that <u>X</u> elected to be treated as an S corporation for federal tax purposes effective as of <u>D1</u> of Year 1, <u>X</u>'s first taxable year, by filing a timely Form 2553, Election by a Small Business Corporation, for <u>X</u>. However, the Internal Revenue service center for <u>X</u> has no record that a timely Form 2553 was filed for <u>X</u> for Year 1.

<u>A</u> represents that <u>X</u> and <u>A</u> filed their tax returns for Year 1 and all subsequent years consistent with the treatment of <u>X</u> as an S corporation.

Section 1362(b)(5) of the Code provides that if: (A) an election under § 1362(a) is made for any taxable year after the date prescribed by § 1362(b) for making such election for such taxable year or no such election is made for any taxable year, and (B) the Secretary determines that there was reasonable cause for the failure to timely make such election, the Secretary may treat such an election as timely made for such taxable

year.

Based solely on the facts and the representations submitted, we conclude that \underline{X} has established reasonable cause for failing to make a timely election to be an S corporation for \underline{X} 's first taxable year. Accordingly, provided that \underline{X} makes an election to be an S corporation by filing a completed Form 2553 with the appropriate service center effective for its Year 1 taxable year, within 60 days following the date of this letter, then such election will be treated as timely made for \underline{X} 's Year 1 taxable year. A copy of this letter should be attached to the Form 2553.

Except as specifically set forth above, no opinion is expressed concerning the federal tax consequences of the facts described above under any other provision of the Code, including whether \underline{X} was or is a small business corporation under § 1361(b) of the Code.

This ruling is directed only to the taxpayer who requested it. Section 6110(k)(3) of the Code provides that it may not be used or cited as precedent.
