This responds to a letter dated September 20, 2002, submitted on behalf of \underline{X} , requesting relief under § 1362(b)(5) of the Internal Revenue Code.

FACTS

<u>X</u> was incorporated on <u>D1</u>. <u>X</u> intended to be treated as an S corporation for federal income tax purposes effective on <u>D1</u>, but the S election was not timely filed.

LAW AND ANALYSIS

Section 1362(a) provides that a small business corporation may elect to be an S corporation.

Section 1362(b) provides the rule on when an S election will be effective. If an S election is made within the first two and one-half months of a corporation's taxable year, then the corporation will be treated as an S corporation for the year in which the election is made. If the election is made after the first two and one-half months of a corporation's taxable year, then the corporation will not be treated as an S corporation until the taxable year after the year in which the S election is made.

Section 1362(b)(5) provides that if no election is made pursuant to § 1362(a), or, if made, the election is made after the date prescribed for making such an election, and the Secretary determines there was reasonable cause for the failure to timely make the election, then the Secretary may treat such an election as timely made for such taxable year and effective as of the first day of that tax year.

 \underline{X} did not file a timely election to be treated as an S corporation under § 1362(a) effective on <u>D1</u>. \underline{X} has, however, established reasonable cause for not making a timely election and is entitled to relief under § 1362(b)(5).

CONCLUSION

Based solely on the facts submitted and representations made, and provided that \underline{X} otherwise qualifies as a subchapter S corporation, we conclude that \underline{X} will be recognized as an S corporation effective $\underline{D1}$. Within 60 days from the date of this letter, \underline{X} should submit a properly completed Form 2553, with a copy of this letter attached, to the relevant service center.

Except as expressly provided herein, no opinion is expressed or implied concerning the tax consequences of any aspect of any transaction or item discussed or referenced in this letter.

This ruling is directed only to the taxpayer requesting it. Section 6110(k)(3) provides that it may not be used or cited as precedent.
