This letter responds to your letter dated January 7, 2003, as well as subsequent correspondence, submitted on behalf of Company, requesting a ruling that the rental income received by Company from the Properties is not passive investment income within the meaning of § 1362(d)(3)(C)(i) of the Internal Revenue Code.

### **FACTS**

Company was incorporated under the laws of State on  $\underline{a}$  and anticipates electing under § 1362(a) to be an S corporation. Company has accumulated earnings and profits.

Company owns, develops, operates, and leases commercial real estate (the Properties) in City. It has <u>b</u> tenants, none of whom is under a net lease.

Company has an on-site office at one of its properties, with  $\underline{c}$  full-time employees. Through its employees, as well as independent contractors, Company provides various services to the Properties in its real estate leasing and management business. These services include regular property inspection; maintenance and repair of building roofs, exteriors, and HVAC systems; cleaning and maintenance of the parking lots, including lighting; mowing and landscape maintenance; supervision of any construction; trash pickup; snow removal; pest control; full janitorial services for one tenant; and utilities for three tenants. In addition to the services provided to tenants, Company handles the usual leasing and administrative functions involved in managing real estate.

Company received or accrued approximately  $\underline{d}$  in rents and paid or incurred approximately  $\underline{e}$  in relevant expenses for  $\underline{f}$  on the Properties. The rental income and expense figures for  $\underline{g}$  are  $\underline{h}$  and  $\underline{i}$ , respectively.

#### LAW AND ANALYSIS

Except as provided in § 1362(g), § 1362(a)(1) provides that a small business corporation may elect, in accordance with the provisions of § 1362, to be an S corporation.

Section 1362(d)(3)(A)(i) provides that an election under § 1362(a) terminates whenever the corporation (I) has accumulated earnings and profits at the close of each of three consecutive tax years, and (II) has gross receipts for each of such tax years more than 25 percent of which are passive investment income.

Except as otherwise provided in § 1362(d)(3)(C), § 1362(d)(3)(C)(i) provides that the term "passive investment income" means gross receipts derived from royalties, rents, dividends, interest, annuities, and sales or exchanges of stock or securities.

Section 1.1362-2(c)(5)(ii)(B)(1) of the Income Tax Regulations provides that "rents" means amounts received for the use of, or the right to use, property (whether

real or personal) of the corporation.

Section  $1.1362-2(c)(5)(ii)(B)(\underline{2})$  provides that "rents" does not include rents derived in the active trade or business of renting property. Rents received by a corporation are derived in an active trade or business of renting property only if, based on all the facts and circumstances, the corporation provides significant services or incurs substantial costs in the rental business. Generally, significant services are not rendered and substantial costs are not incurred in connection with net leases. Whether significant services are performed or substantial costs are incurred in the rental business is determined based upon all the facts and circumstances including the number of persons employed to provide the services and the types and amounts of costs and expenses incurred (other than depreciation).

## CONCLUSION

Based solely on the facts and representations submitted, we conclude that the rents Company receives from the Properties are not passive investment income under § 1362(d)(3)(C)(i).

Except for the specific ruling above, we express or imply no opinion concerning the federal tax consequences of the facts of this case under any other provision of the Code. Specifically, we express or imply no opinion regarding Company's eligibility to elect to be treated as an S corporation. Further, the passive investment income rules of § 1362 are completely independent of the passive activity rules of § 469; unless an exception under § 469 applies, the rental activity remains passive for purposes of § 469.
