This responds to your letter dated August 5, 2004, and subsequent correspondence submitted on behalf of \underline{X} , requesting that the Service grant \underline{X} an extension of time to elect to be treated as an association taxable as a corporation under § 301.7701-3(c) of the Procedure and Administration Regulations.

The information submitted states that \underline{X} is a limited liability company formed under the laws of State 1 on $\underline{d1}$. \underline{X} is wholly owned by \underline{Y} , a corporation formed under

the laws of State 2. \underline{Y} is wholly owned by \underline{Z} , a corporation formed under the laws of State 1. \underline{Z} intended that \underline{X} elect under § 301.7701-3(c) to be treated as an association taxable as a corporation effective $\underline{d1}$. However, \underline{X} inadvertently failed to timely file a Form 8832, Entity Classification Election.

Section 301.7701-3(b)(1) provides guidance on the classification of a domestic eligible entity for federal tax purposes. Generally, a domestic eligible entity is disregarded as an entity separate from its owner if it has a single owner unless the entity elects otherwise. To elect to be classified other than as provided in § 301.7701-3(b), an eligible entity must file a Form 8832, with the service center designated on that form.

Section 301.7701-3(c) provides that an entity classification election must be filed on Form 8832 and can be effective up to seventy-five (75) days prior to the date the form is filed or up to twelve (12) months after the date on which the form is filed.

Section 301.9100-1(c) provides that the Commissioner may grant a reasonable extension of time to make a regulatory election, or a statutory election (but no more than 6 months except in the case of a taxpayer who is abroad), under all subtitles of the Internal Revenue Code except subtitles E, G, H, and I. Section 301.9100-1(b) defines the term "regulatory election" as an election whose due date is prescribed by a regulation published in the Federal Register or a revenue ruling, revenue procedure, notice, or announcement published in the Internal Revenue Bulletin.

Sections 301.9100-1 through 301.9100-3 provide the standards the Commissioner will use to determine whether to grant an extension of time to make the election.

Section 301.9100-2 provides the rules governing automatic extensions of time for making certain elections.

Section 301.9100-3 provides the standards the Commissioner will use to determine whether to grant an extension of time for regulatory elections that do not meet the requirements of § 301.9100-2. Under § 301.9100-3, a request for relief will be granted when the taxpayer provides evidence to establish to the satisfaction of the Commissioner that (1) the taxpayer acted reasonably and in good faith, and (2) granting relief will not prejudice the interests of the government.

Based solely on the information submitted and the representations made, we conclude that the requirements of \S 301.9100-1 and \S 301.9100-3 have been satisfied. As a result, \underline{X} is granted an extension of time of 60 days from the date of this letter to file a Form 8832 with the appropriate service center and elect to treat X as an

association taxable as a corporation effective <u>d1</u>. A copy of this letter should be attached to the Form 8832. A copy is enclosed for that purpose.

Except as specifically set forth above, no opinion is expressed concerning the federal tax consequences of the facts described above under any other provision of the Internal Revenue Code.

This ruling is directed only to the taxpayer(s) requesting it. Section 6110(k)(3) provides that it may not be used or cited as precedent.
