The port has disputed the amount of the receivable due to the Company, and the matter is currently being litigated.

You were notified in a letter dated August 5, 2003, that your request had been tentatively denied. A conference of right was held on September 22, 2003. At the time, a decision was made to await the outcome of the pending litigation mentioned above.

During a telephone conference with the Pension Benefit Guaranty Corporation ("PBGC") on December 10, 2004, you stated that the Company has not made contributions to the plan, including the amortization payments that would be due if a waiver of the minimum funding standard were granted for the plan year ending for the plan years ending and The funding deficiency has grown rapidly, and the Company's current plan is to resolve the above-mentioned litigation, begin selling off the Company, and eventually terminate the Plan. Because it is unreasonable to assume that the Plan will continue only if a funding waiver is granted, your request for a waiver of the minimum funding standard for the plan year ending has been denied.
