## People on a Pension: You May Not Be Required To Have Federal Tax Withheld



## Are you required to file?

The Internal Revenue Service (IRS) is sending this information as part of our customer service and outreach efforts to reduce taxpayer burden. We hope this information helps you decide to stop the withholding on your pension income. Changing your Federal withholding will prevent you from filing unnecessary returns, and you will receive larger pension checks throughout the year.

To find out more about Form W-4P and claiming an exemption for 2000, you can access

the IRS on the Internet Web Site. Connect to **www.irs.gov**, select the forms and pubs option, follow the directions to access the information on Form W-4P. You can reach us by phone 24 hours a day, 7 days a week during the filing season. After April 17, we will continue to offer around the clock service for refund and account callers, and we will be available for tax law assistance Monday through Saturday from 7am until 11pm.

**If you can answer yes to both questions below, you may not have to file a 2000 Federal income tax return.**

*Do you have Federal income tax withheld from your pension?*

*Will you file for 1999 only to get a refund of money withheld from your pension?*

You can probably avoid filing a 2000 Federal tax return in the year 2001 if you advise your pension company to stop Federal withholding. You can stop withholding simply by filling out the enclosed **Form W-4P**, Withholding Certificate for Pension or Annuity Payments, and mailing it to the company that sends you your pension checks. If you do not have to file a Federal tax return, you will save time. If you usually pay someone else to prepare your Federal return, you will also save money.

To see if this might work for you, fill out the enclosed worksheet to find out if you owe taxes for 1999. If your income is less than the minimum amount shown on the chart, you will only have to file a 1999 tax return to receive a refund of your pension withholding. If your income in 2000 will be about the same as it is in 1999, it is likely that you will not owe any taxes for 2000 either. If you mail the Form W-4P to your pension company in early December of 1999, they will have time to stop the withholding before another year starts. You most likely will not have to file a 2000 Federal tax return.

**Send a Form W-4P to your pension company by early December 1999**

**SO**

**Your pension company can stop deducting Federal taxes for all of the 2000 tax year**

**THEN**

**You probably will not have to file a 2000 Federal tax return.**

**Reminder:** This applies only to your Federal tax return. State filing requirements are different. You should contact your state or local tax office if you need this information.

## Computing Your Total Gross Income

*Note:* You can use this worksheet only if your taxable income for 1999 and 2000 is from one of the sources listed below.

1. Wages, salaries, tips	1. \$

3. Dividend income (Include gain on sale of stocks or bonds)	3. \$
4. Taxable retirement income (Taxable Pension, Annuity, IRA Distributions)	4. \$

**Caution:** You may also be required to file return if you owe any special taxes, such as tax on an IRA or other retirement plan.

## Determining Your Filing Requirements

Use this chart to see if you must file a return. If line 5 is less than the amount shown in the chart below, a Federal tax return does not have to be filed.

**Note:** If you turned 65 on January 1, 2000 you are considered to be 65 at the end of 1999.

<b>IF your filing status is...</b>	<b>AND at the end of 1999 you were...</b>	<b>THEN you do not need to file a return if your gross income is less than...</b>
Single	under 65 65 or older	\$ 7,050 8,100
Married filing jointly*	under 65 (both spouses) 65 or older (one spouse) 65 or older (both spouses)	\$12,700 13,550 14,400
Married filing separately	any age	\$2,750
Head of household	under 65 65 or older	\$ 9,100 10,150
Qualifying widow(er) with dependent child	under 65 65 or older	\$ 9,950 10,800

\* If you did not live with your spouse at the end of 1999 (or on the date your spouse died) and your gross income was at least \$2750, you must file a return regardless of your age

Do not mail to the IRS. Give to your pension company.
